Mrs Lesley Lynn (Chair) to move that "This Synod re-affirms that care for God's creation is foundational to the Christian gospel and central to the church's mission and, recognising (a) the importance of working towards a future which does not depend on fossil fuels; (b) the need to both develop alternative energy supplies and reduce the demand for energy before freedom from fossil fuels can be achieved; and (c) the central role that large energy companies have to play in developing alternative energy supplies, agrees that it will continue to invest in Shell and BP only while those companies have a clear strategy aligned with the Paris Agreement goal to limit the increase of average global temperature to 1.5 degrees Celsius above pre-industrial levels ."
