#### **Bob Chambers**

Candidate for House of Laity, General Synod (Chichester Diocese)



It would be an honour and a privilege to serve on General Synod (GS), at what is clearly a significant and challenging time for the Church of England (CofE). Despite the pressures, I believe the CofE still has a precious and unique place in our society, with all sorts of missional opportunities. The commands to love both God and neighbour are non-negotiable, and those efforts start close to home for each of us – with our families, those we live next door to, or work alongside – seeking to share the good news of the gospel of Jesus with them, supported by our own church community. Holding faithfully to the timeless truths of Scripture, trusting our all-powerful and eternal Heavenly Father with confidence, we must not be swayed or cowed by cultural shifts and pressures.

I am very thankful for the various experiences I've had over the years, that I believe now equip me well for this opportunity. Standing for election is not something I have entered into lightly or in my own strength; rather, it is the culmination of several years of reflection and prayer, and a growing sense that I should express an interest in serving in this way. Having followed some of the debates and decisions from recent GS sessions, my unease and motivation have grown stronger, and I could no longer simply observe and wonder.

I grew up in a church-going family living in greater London and was part of an active Crusader youth group in my teens (now 'Urban Saints'). In addition to attending our own local parish church, I sang for several years as a treble in a <u>chapel choir in central London</u>, which provided a taste of a very different liturgical tradition. On leaving school, my gap year included a short-term mission trip to Bolivia, before heading to Sheffield for a Business Studies degree; as part of my degree course, I spent a semester on exchange in Melbourne. As a student, I led the Christian Union on campus and attended <u>Christ Church</u>, <u>Fulwood</u> (Sheffield) and <u>St Jude's</u> (Melbourne). My placement year included a season on residential staff at <u>CYE</u> Christian activity centre in Chichester Harbour – prompting my dissertation on 'Human Resource Management at Christian Outdoor Centres', as well as working for Marks and Spencer in their Bradford and Leeds high street stores.

My father died during my final year at university. On graduating, I took up a place on the NHS Management Training Scheme, which led to a series of managerial roles in hospitals in Lincoln, Leicester and Cardiff, and a secondment to the Civil Service (in the Health Strategy team at the Welsh Office Health Department), over a total period of seven years. On leaving the NHS, I joined a management and leadership development consultancy, and alongside that was involved with a small charity sponsoring Christian university students across Romania. Six years later, I moved to the relief and development agency World Vision UK in an organisational development role. That in turn led to a related opportunity in the World Vision Southern Africa Regional Office, based in Johannesburg; my family and I lived there for three years, during which time my work took me to various countries across the continent.

On returning to the UK in 2013, I joined the <u>Christian mission agency Feba</u> (the Far East Broadcasting Association), initially as Director for Transition before being appointed Chief Executive in 2014. I am responsible for leading Feba's UK ministry, as well as serving in an elected position on the global Executive Committee (ExComm) of our international association. The role involves leadership of the team and oversight of all day-to-day operations, including a portfolio of partnerships and projects across Africa, Asia, Eastern Europe and the Middle East, plus our various fundraising and communications activities with Feba's UK supporter base – comprised of individuals, churches and grant-making trusts. I have been married to my wife, Rachel, for 23 years and we have two sons, aged 19 (at university) and 16 (awaiting GCSE results). As a family, we have been attending <u>St Margaret's church in Angmering</u> since we arrived in the area in 2013, where I currently serve on the PCC and lead a homegroup. I have previously been Foundation Governor at the local Church of England primary school, where my wife works part time.

In the course of various relocations and travels with study and work over the years, I've experienced a variety of church traditions and cultures, for which I am thankful. In Cardiff, for example, my wife and I attended

Highfields (a thriving FIEC church), and in Johannesburg we worshipped at Northcliff Union Church (with roots in the Baptist tradition). An underlying commitment to faithful, orthodox Bible-based teaching and Christ-centred worship has been a prerequisite, with the Church of England being our default throughout. Whilst living in Warwickshire for seven years, we were part of our small local village church (with a population of barely over 500 people) and invested heavily in all that was going on there, including several years of us leading a children's group, and me serving on the PCC and as Church Warden. We also attend the Keswick Convention regularly.

My career to date has spanned a fairly diverse range of roles and sectors, each of which has taught me valuable lessons. Alongside the main task responsibilities of the positions I've held, I have at different times been elected to the National Council representative bodies for the Institute of Health Service Management (was IHSM, now IHSCM) and the Chartered Institute of Personnel and Development (CIPD), of which I am still a Chartered Member. Those past governance roles and my current ExComm position – coupled with experience of PCCs, as school governor and Churchwarden – provide a useful basis for the somewhat similar function of the CofE's national body. The ability to operate at a strategic level and see 'the big picture', yet without losing sight of important detail, is something that others have observed in me. Being comfortable dealing with all manner of operational matters (including financial, legal and personnel) has been a prerequisite, and working effectively cross-culturally with different personalities and characters has been essential, too.

Items to be included on the General Synod agenda in the coming months are all important in their own way, and some are particularly complex and contentious. It is probably fair to say that the ongoing work around *Living in Love and Faith* is quite likely to grab the headlines more than most other topics, but GS should not be defined solely by this as a single issue body. For reference, my personal view is that the marriage relationship between one man and one woman is a foundational, integral and essential part of God's perfect design, and all other patterns of sexual relationship fall outside of what He intended. It is absolutely true to say that there are all sorts of areas in which we each sin (certainly myself included): we all fall short of God's standard in some way, and none of us can be right with Him except by grace – by accepting the gift of forgiveness, with Christ alone having paid the price on our behalf. In uncertain times, I believe it is critically important that the church proclaims unswervingly this universally good news, as we seek to inspire people to trust and follow Him.

Other important matters such as families and children, safeguarding, migration, slavery and trafficking (both historic and modern day), the war in Ukraine and tensions in the Middle East, and climate change also feature in our news and on the church's agenda, in a context of considerable financial challenge and disunity across the wider Anglican Communion. Each of these requires a prayerful, biblical, and carefully considered response if the Church of England is to bear faithful witness to the living Lord Jesus in a messy and hurting world.

As I said at the beginning, I acknowledge my dependence on God: standing for this election is first and foremost an act of obedience to His stirring. As I reflect on what I learned and experienced of local church from my parents – and from my grandparents too (all of whom were actively involved in various ways), and consider the CofE as we know it today, I wonder what it will be like for my own sons in adulthood. My prayer is that it would be a vibrant and faithful witness to the living God, honouring Him in submission and obedience to His word, relevant and accessible to all, that we might be worthy of the title 'Bride of Christ'. I would certainly give of my best to that end if elected.

"If elected to General Synod, I will endeavour to grow in faith, I pray God will challenge and enable me to honour Him, to serve the Synod and represent the Diocese of Chichester for the glory of God and his Kingdom. I will advocate through prayer and fasting to learn more about where God is leading his Church: to share his inclusive love for all, to be good stewards of his creation and to see the Kingdom grow through ministry and mission".

Grace and Peace to you in Jesus name! First of all, I am a Christian and adhere to the Creeds, the Word and the Spirit. While serving in Mission, I have learned the joy of diversity of different church traditions; of observing different faiths, of seeing God's inclusive love for everyone: so like Paul, I have learned to be content in knowing God is with me and seeks only good for his creation, for he is Love. This is summed up I believe in Prov. 22:2 which was part of my call to mission vocation. 'The rich and poor have this in common, the Lord is maker of them all'.

If elected, I will serve to seek God's will in current and emerging issues. My mission overseas experience of living in Hindu, Buddhist and Islamic countries of 33 years have given me intimate knowledge of cross cultural issues. My passions are for the environment, community, diversity, social and spiritual growth where the Mission of the Church continues to meet temporal and spiritual challenges. Trends develop, we have become familiar with sustainability, climate change, carbon reduction, net zero: new concepts are developing such as net gain, habitats and nature-positive – and so we come back to God's creation and his charge to be good stewards of His garden!

Having just returned from long term service overseas, I have settled in Seaford, where I moved in 2013 when I started my current employment in Brighton. I am a Chartered Engineer, working for most of my career constructing Hydro Electricity Projects, most recently in Pakistan where I was lead Consultant on a \$750M project. My employment is in an engineering consultancy and am Fellow of the Institution of Civil Engineers.

Now that I am 'home', I want to explore how God will use me in further ministry and mission; maybe through this opportunity if elected to serve on the General Synod.

I believe my professional career has been planned for me by my Heavenly Father, as he guided me towards mission service with Church Mission Society. After my first tour, I was to speak at a CMS enquirer's weekend for others interested in mission. Alison Richardson was also attending to speak on her experience in Iran, being evacuated with others such as Jean Wadell and Bishop Teghani Tafti. Alison was preparing with CMS for mission service in Sierra Leone as a Midwife, but God had it all lined up: we married and went to Nepal! We were seconded to the United Mission to Nepal where we lived and worked building hydropower projects. Alison developed health clinics. When there, we saw the Holy Spirit work: hearts were changed, churches formed and the Kingdom, growing. Some people call this Business in Mission. As well as hydro projects, we also installed water systems, sanitation, poly clinics, schools, disabled kids centre, hospitals, bridges, roads and along those roads (usually walking) we had many journeys, talking to people and seeing their hearts change. We were thankful to see the Kingdom grow from 10,000 Christians in 1983 to about one million when we left in 2013 - it is like the Acts of the Apostles, chapter 29! Being fluent in Nepali, I led, taught and preached in our small and growing fellowships, saw signs and wonders in people's lives and whole communities.

Our two 'mishkids' were born and grew up in Nepal: for me, I was glad they had that upbringing, very different from my own in the 'troubles' of N. Ireland. My son has also served with Mission Aviation Fellowship in Australia and South Sudan.

Throughout my mission service in Nepal, we lived in relatively primitive conditions, close to nature and the environment. We learned about sustainability and climate effects before they became popular here in the '10-40 window'. I have learned about Kingdom investment and the hope that we have in Jesus Christ and His great love for his creation.

With engineering geometry in my veins, some of my spare time is in drawing Celtic knotwork and calligraphy. Now back in UK, I hope to see the odd rugby or football match!

## Why Am I Standing?



- Recently retired, I believe that I have the time and life/work experience to be able to serve the
  church through General Synod. Both my life growing up in the Church of England as a vicar's
  daughter, and my experience working as a Managing Director on strategic issues in a global
  Investment Bank, have given me skills pertinent to General Synod. I am able to navigate large
  organisations to tackle complex detail, as well as understand the big picture issues and have the
  interpersonal skills to work well with others. I believe that equips me well for the complexity of issues
  that General Synod has to deal with.
- I believe that at its best the church, through God's grace, can live out the Kingdom of God on this earth as in heaven and that the world is now, more than ever, crying out for God's saving grace and His Kingdom. My deepest longing is for people to know that, no matter who they are and what they are going through, Jesus loves them and that they can rely on His sustaining comfort and power through the ups and downs and challenges of life. The great God and creator of the whole universe cares like a loving parent for each of us as if we were the only one.

## **Work Life**

- I worked in Human Resources in the City in a global Investment Bank for almost 20 years, with my last position being Managing Director, Global Head of Diversity and Inclusion. I worked with the board and was responsible for initiating our involvement with "London Schools and the Black Child" along with many other deeply inspiring initiatives across the whole spectrum of diversity.
- I completed a 2 year Psychodynamic Counseling Skills course with the Westminster Pastoral Foundation and more recently an Ana Chaplaincy course through my volunteering with 'Linking Lives' - a church based organization that seeks to reduce loneliness by befriending lonely and isolated people.

## My Faith and Church

- I gave my life to Jesus aged 6 and grew up in the Church of England as my father was an ordained priest. My early life was steeped in the church, first with my father as a university chaplain and Old Testament scholar, then living in Nigeria as the family were in the mission field with CMS, and later returning to England and my father working as a parish priest and then for the Board of Mission and Unity in Church House. Through this I have experienced different parts of the church, at home and abroad, both locally and in national responsibilities. I have attended churches with different traditions during my adult life from high church with incense, traditional liturgy and worship, through to more free-form evangelical churches with modern worship songs. Both represent aspects of church that I love. I have experience of rural and inner city churches and understand the challenges of both, and they have supported my faith in living out the inclusive love and welcome of the gospel message.
- I am grateful to be active within my current church, St. John's Meads, Eastbourne. I am on the PCC, lead a Bible Study homegroup for post Alpha participants, lead intercessions, do readings, help in Sunday School, am a member of our intercessory prayer group and have co-led a monthly church prayer meeting.
- From my working life I understand issues around good governance, and I am on the Deanery and Diocesan Synod.

## **Issues Facing the Church**

**Discipleship:** I am excited by mission - bringing more people to faith - but my deepest passion is for how we help people in their journey of faith - sustaining their walk with God especially when the going gets tough. I am passionate about people not just believing that God exists, but really having a personal relationship with Him. I long for the Bible and prayer to be both made accessible and understood as the enormous help they are in understanding who God is, who they are and their value to God.

The Local Church: The local parish church is of such vital importance as the cutting edge of mission and outreach, a place which brings people together to encourage each other on their journey of faith and to serve and care for local people in the ups and downs of life. It is where the Church is at its most intimate and impactful with the world. My experience of leading and pastoring a post Alpha Bible Study group with a group of local people has given me a renewed appreciation for how key the local church is.

**National and International Life**: I believe that the church has a vital role in challenging social injustice both nationally and internationally. At a time of such division and increasing conflict in the world, the church must speak out the gospel of justice, peace and reconciliation. It has a crucial role to speak for the voiceless and the oppressed.

**Racial Justice:** Unfortunately racism is still a problem in our world. I have felt a lifelong concern that it should be seen, recognised and confronted effectively whenever it occurs, including within the church. I believe that racism and unconscious bias should be included as a topic in the training of ordinands.

**Inclusion in the widest sense:** I long for the church to welcome and respect all people regardless of their gender, ethnicity, ability or sexuality as each person is made in God's image and is a precious child of His. We are called to love our neighbour as ourself and we must strive as a church to ensure that this is what distinguishes us from the world. I believe that my experience and understanding of working in Diversity and Inclusion in a global multinational organisation helps equip me to understand how the church can be a church for everyone.

**Climate Change:** We are called to care for God's wonderful creation and I believe that the church has an important role to play in its stewardship.

Clergy wellbeing: Having several members of clergy in my family, I am very cognisant of the particular strains, stresses and loneliness that can accompany the clergy life. I believe that the church must ensure it does not place further stresses upon its clergy and that it has appropriate means and support to help clergy and their families when they struggle. Clergy are so valued for giving their lives in service and the laity must speak up for them to ensure they are nurtured and protected.

Why stand for General Synod?

I hold an orthodox evangelical view of the bible, God's word, and I will be working to see this maintained where I can. I believe that marriage is the union of one man with one woman. I disagree with the motion passed at the recent General Synod to approve stand-alone services of blessings for same sex couples.

I would be particularly interested in moves to encourage church growth and promoting youth and families' ministry. In many areas the church is seen as irrelevant to day to day life and, working with other local churches, this view needs to be changed. The Church of England has a physical presence in every community in terms of buildings but this needs expanding to involve the people in the areas around these churches and tell them the good news of Jesus.

I would also be keen to help ensure there is still freedom to preach the good news of Jesus Christ in a world where secularism is predominant.

### Church involvement:

We joined St Johns Southbourne thirty years ago when we moved south. I have been churchwarden, twice, and treasurer for 3 years each. My interests have always been mission and young people so I have served on the mission team and worked in various youth groups. I currently help lead a group for year 6-9 on a Sunday afternoon. Our church runs a coffee shop on certain weekday mornings and I enjoy helping there and meeting new people and hopefully helping them become involved in some aspect of the church.

Before becoming church warden for the second time I served on Deanery Synod for a few years.

During the Coronavirus epidemic and lockdown, I helped to run our church FreeShop with a team of church people and others from the village, providing free food for at least 20 families in the local community I have volunteered with Christians Against Poverty and currently Homestart, both of which are based in Chichester. Homestart provides weekly support for parents who are going through a difficult time and

have pre-school children. I really enjoy sharing books with the children.

A little about myself:

Born and brought up on the Isle of Wight as a nominal catholic, I became a Christian at Liverpool University while studying Zoology. After graduating and marrying Alan I worked for Glaxo Pharmaceuticals for eight years before working as a missionary in Northern Nigeria for four years with

Tearfund. My husband helped run the medical programme and I helped in the pharmacy. We could not openly evangelise but hoped to show by our lives and witness the love of God to those around. We returned to the UK in 1990, moved south, had two lovely boys and I was lucky enough to be able to be at home with them full time in their younger years. When they started secondary school I retrained as a teacher, definitely much harder to study later in life and worked at a secondary school in Bognor Regis with young people at risk of exclusion and later on with the looked after children. I retired early a few years ago and have enjoyed more time with Alan and holidays to visit the boys and their families and walk and birdwatch

### Why General Synod?

The Church of England has a vital role to play in our nation by pointing an increasily post-Christian England to Christ.

I grew up in the Church of England, attending my local parish church. I have been closely involved with both revitalising existing churches, and starting new ones in both Catholic and charismatic worship traditions.

One of the greatest privileges of my life has been to serve in the Diocese of West Malaysia for 8 years being part of a team who was invited by Archbishop Moon-Hing to plant a new church in Kuala Lumpur.

I really believe in the Anglican Communion and the Church of England, and that this is a key time for us as a church to listen and learn from the global communion.

I think I would bring valuable experience to Synod as a mother, person living with disability, lover of theology, and having had a broad experience of Anglican worship traditions both here and abroad. ### Jonathan Sharp - General Synod Election Address

RT Kendall famously observed 'God has an opinion about everything'. This is both challenging and comforting. It brings a sense of immediacy and concentrates the mind and heart on what God's opinion would be - for personal issues, for what our churches teach and of course at General Synod. I believe we have to start with the Bible, helped by the Holy Spirit, and refined in discussion with others. We also have the Canons and Formularies to keep us on track.

General Synod's main roles are approving liturgy & doctrine changes, setting budgets and maintaining good relations with other churches.

If elected, I'd join those who seek to follow the Church of England's orthodox biblical witness because God's way is always going to be best for us. His loving direction is sometimes a severe mercy but never to be scorned.

#### Liturgy & doctrine

The dominating issue is the LLF process - which really needs to be reversed, but given the current situation the main concern now is to put legal structures in place to support parishes that continue in the orthodox faith. This could be a big change. We then need to move away from this divisive issue to focus on our urgent responsibility to bring grace, hope and Godly wisdom to our nation.

#### **Budget**

The Church's ample financial resources should be used principally to support parish ministry. We have to recognise that God is at work in the smallest gatherings as well as in festive crowds, so parishes need to be prioritised in financial support and in ministry resources. A strong long-term commitment to biblically-faithful parish communities will help restore confidence in those considering full-time ordained leadership. It will also encourage potential lay leaders to invest time and energy in training.

#### External relationships

We also need to re-establish good relations with our fellow global majority Anglicans who no longer recognise the authority of the Archbishop of Canterbury. This will only happen if the LLF measures are reversed or a separate structure established.

There is a lot to be thankful for in our churches - welcoming strangers, great children and youth work, warm friendships, God's presence in our lives, joyful worship, encouraging teaching, lives changed, support for those in need. We need to nourish and build on this.

It's also encouraging to see biblical principles for human flourishing being more confidently expressed in the wider media. In the midst of many personal and collective challenges the words and grace of our creator need to be heard.

About me - I have served on PCC, Deanery and Diocesan Synod, so I'm aware of the general structure and workings of these assemblies. I have been part of a Church plant and also long-established congregations in Plymouth and London but mostly in Brighton & Hove.

My background is in software development having worked for a British Telecom subsidiary and more recently for the UK branch of a New Zealand firm, building e-commerce and online learning systems. I've also developed a cultural-apologetics website. Off-duty I enjoy sailing with family and friends.

#### About me - my beliefs

I have always grown up knowing about Jesus. Through my time at university, my faith grew and I became involved in the Christian Union, leading small groups in Bible study. The Word of God is paramount to me and I believe it is essential to read His word daily, pray and seek His voice in all that I do. #### **Dear Elector**

I am a lifelong Christian (my late father was a Reader) and I have grown through the usual childhood roles from chorister and Sunday School member to Sunday School leader. For the past 4 years I have been a Children's and Families Worker at St Andrews Church, Tarring in Worthing, building relationships in the community with schools, families and our own church community. In the school holidays I run Craft and Play sessions. In term time I help at Baby and Toddlers Group each Wednesday, and I run a pre-school session in church on Thursdays with a different story and craft each week (and of course time to play!)

In my previous job as a Teaching Assistant I was involved in the RE in school, helping to plan and deliver class-led worship and services at the local church at Harvest, Christmas, Easter and the end of term.

I believe it is important to encourage, support and engage with the children, young people and families in the local community. I have for the past 2 years run a Warm Hub space with Mothers' Union once a week after school from November to the end of February for families

recommended by local schools who are struggling with the cost of living. We were able to provide a bag of food for each family thanks to the generosity of the church and others.

For the last 12 years I have been a leader of the Diocesan group for the Children's Pilgrimage to Walsingham, and more recently also a leader for the Youth Pilgrimage to Walsingham. Our numbers increase each year as children grow in faith and confidence.

We need to invest in our Church schools, ensuring that children and young people can explore and develop in faith. I have learnt a lot about this during my time as a Governor at a Special school for children with disabilities – my experience here ties in with the recent General Synod debate on 'The Human Dignity of Disabled Children'.

In an era when Safeguarding is a vital priority for any community, especially the Church, I believe that my experience and my concern for the wellbeing of our children and young people make me a good candidate to represent our Diocese on General Synod.
